Arid Zone Research Institute (AZRI), Umerkot, Sindh as per relevant rules/ regulations and Govt. policy invites sealed bids from the reputable suppliers/companies register with GST/ Income Tax Department for the Procurement of Tractor along with Accessories under PSDP Project, "Strengthening/ Up-Gradation of Agricultural and Livestock Research System of Arid Zone Research Institute, Umerkot, Sindh" fiscal year 2018-19 having relevant experience for supply of these items at AZRI, Umerkot.

2. The eligible firms/Suppliers and dealer (not involved in litigation/legal inquiries with PARC and allied institutes) may submit bid on the terms & conditions and technical specifications in the tender document which can be purchased by the interested firms from Directorate (AZRI), Umerkot, Sindh on any working day from (9:00 AM to 5:00 PM) Monday to Friday from 02-04-2019 on written request of the firm/ company letter head/pad with firm registration certificate and GST / NTN number along with pay order / bank draft amounting to Rs.1000/- (Non-Refundable) drawn in favor of Director AZRI, PARC Umerkot, Sindh.

3. Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit their technical and financial bids as per format in separate envelope. The bids will be received on or before 18-04-2019 by 1100 a.m., and opened on the same day at 1130 a.m. at AZRI, Umerkot, Sindh in the presence of bidders or their nominated representatives who choose to be present. No tender will be sold on date of opening of tenders.

4. Each bid should be accompanied with 2% earnest money of quoted bid amount in shape of bank draft or pay order in favor of Director AZRI, Umerkot, Sindh. The conditional bids or the bids without earnest money or containing less earnest money shall not be accepted as per PPRA Rules. The prices quoted should be included with all taxes/ GST (where applicable). The payment would be made after delivery of tractor and accessories at PARC-AZRI Umerkot-Sindh.

5. The payment of all taxes is the responsibility of the firms. PARC reserves the right to reject any or all bids proposals or may cancel the tender at any time prior to acceptance of a bid or proposal. However Director AZRI, Umerkot, Sindh shall upon request communicate to any firm who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds. Director AZRI, PARC Umerkot, Sindh may decrease/ increase the quantity of equal items.
