The bids will be received on or before 30-04-2020 by 1100 a.m., and opened on the same day at 1130 a.m. at PARC, HQs, Islamabad in the presence of bidders or their nominated representatives who choose to be present. No tender will be sold on date of opening of tenders. The supplies/ Installation of machinery will be at PARC, Islamabad and its sub-component NARC/Different project locations.

Each bid should be accompanied with 2% earnest money of quoted bid amount in shape of bank draft or pay order in favor of PARC, Islamabad. The conditional bids or the bids without earnest money or containing less earnest money shall not be accepted as per PPRA Rules.

The payment of all taxes is the responsibility of the firms. PARC reserves the right to reject any or all bids proposals prior to acceptance of a bid or proposal. However PARC shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds.
