No tender will be sold on date of opening of tenders. The supplies of Furniture /repairs will be for PARC Cafeteria, Islamabad.

Each bid should be accompanied with 2% earnest money of quoted bid amount in shape of bank draft or pay order in favor of PARC, Islamabad. The conditional bids or the bids without earnest money or containing less earnest money shall not be accepted as per PPRA Rules.

However PARC shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds.
