Pakistan Agricultural Research Council (PARC) Islamabad as per relevant rules/regulations and Govt. policy invites sealed bids for procurement of Solar Pumping from the reputed firms/ companies, Suppliers during the year 2019-20. The firms/ companies registered with income tax and GST department having relevant experience to conduct such activities are invited to quote their rates/ bids for solar pumping system to be delivered/ installed at National Sugar & Tropical Horticulture Research Institute (NSTHR), PARC, Makli, Thatta, (Sindh).

2. The eligible firms/companies those authorized and capable (and not involved in litigation and legal inquiry with PARC or other agency) may bid as per terms & conditions and quantity of solar pumping system mentioned in the tender document. The tender document can be purchased by the eligible firms from PI/Director NSTHRI, PARC, Makli, Thatta, (Sindh) on any working day from (9:00 AM to 5:00 PM) Monday to Friday from 03-06-2020 on written request of the firm/ company letter head/pad with firm registration certificate and GST / NTN valid number along with pay order / bank draft amounting to Rs.1000/- (Non-Refundable) drawn in favor of, Director NSTHRI, PARC, Makli, Thatta, (Sindh).

3. Bidders who fulfill and abide by the prescribed terms & conditions contained in tender document may submit their technical and financial bids as per format in separate envelope. The bids will be received on or before 18-06-2020 by 1100 a.m., and will be opened on the same day at 1130 a.m. at NSTHRI, PARC, Makli, Thatta, (Sindh) in the presence of bidders or their nominated representatives who choose to be present. No tender will be sold on date of opening of tenders.

4. Each bid should be accompanied with 2% earnest money of quoted bid amount in shape of bank draft or pay order in favor of PARC, Islamabad. The conditional bids or the bids without earnest money or containing less earnest money shall not be accepted as per PPRA Rules.

5. The payment of all taxes is the responsibility of the firms. PARC reserves the right to reject any or all bids proposals or may cancel the tender at any time prior to acceptance of a bid or proposal. However PARC shall upon request communicate to any firm who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds. PARC may decrease/increase or omit the quantity of any items from tender list.
