The Vehicle Authorization Committee, during its 42nd meeting held on 25th October, 2024 expressed serious concern on the tendency of retention of vehicles of closed / completed projects which has led to multiple audit observations of various Ministries, Divisions, Attached Departments and Sub-ordinate offices. Accordingly, the Committee decided to convey all the Ministries, Divisions, Attached Departments and Sub-ordinate offices to surrender all vehicles of closed / completed projects to the Central Pool of Cars of the Cabinet Division complying with rule 3(4) of the Rules for the Use of Staff Cars 1980 in letter and spirit which states:

'The Cabinet Division will arrange for the upkeep and maintenance of a staff car which becomes surplus to the requirements of Minister, Minister of State, Advisors or any other dignitary or office holder or on completion of project."

2. Going by the above regulatory requirement, all the Ministries, Divisions, Attached Departments and Sub-ordinate offices are requested to surrender above category vehicles immediately to the Cabiner Division for upkeep/maintenance and for the use of official duties of the Federal Government.

3. Compliance in this regard shall be taken up by the Vehicles Authorization Committee in its next meeting and further actions to be proposed accordingly.
