Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit their bids on using E-PADS portal and also submitted hard copy in the office of Assistant Director (Procurement) PARC Islamabad, as per format on or before 11-09-2025, by 1100 hours positively and bids will be opened on the same day at PARC (HQs) at 1130 Hours in presence of bidders or their nominated representatives who choose to be present. No tender will be sold on date of opening of tender.
