

The tender document can be purchased from PARC Room # 231 (2<sup>nd</sup> Floor) on any working day during office timing, Monday to Friday from 29-11-2024 on written request of the firm/company letter head/pad with firm registration certificate and GST & NTN along with pay order / bank draft amounting to Rs.3,000/- (Non-Refundable) drawn in favor of PARC, Islamabad. Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit their bids (technical and financial in separate envelopes) on using E-PADS portal and also submitted hard copy in the office of Director Procurement, PARC, HQs, as per format on or before 16-12-2024, by 1100 hours positively and bids will be opened on the same day at 1130 Hours in presence of bidders or their nominated representatives who choose to be present. No tender will be sold on date of opening of tender.

Each bid should be accompanied with 4% earnest money of quoted bid amount in shape of bank draft or pay order in favor of PARC Islamabad. The conditional bids or the bids without earnest money or found less earnest money shall not be entertained/accepted as per PPRA Rules.

The payment of all taxes is the responsibility of the firms. PARC reserves the right to reject any or all bids proposals or may cancel the tender at any stage prior to acceptance of a bid or proposal. However PARC shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds. PARC may decrease or increase in the job activity of the Vehicle or may revise it as may deem appropriate.
