The quoted rates /bids shall be valid up to 30-06-2026.

Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit their bids (technical and financial) on using E-PADS portal as per format on or before 02-02-2026, by 1030 hours positively and bids will be opened on the same day at 1100 Hours at PARC HQ in presence of bidders or their nominated representatives who choose to be present.
4. Each bid should be accompanied fix amount with **Rs.50,000/-** earnest money in shape of bank draft or pay order in favor of PARC, Islamabad. The conditional bids or the bids without earnest money or containing less earnest money shall not be accepted as per PPRA Rules.
5. The payment of all GST/applicable taxes is the responsibility of the firms/companies. PARC reserves the right to reject any or all bids' proposals prior to acceptance of a bid or proposal. However, PARC shall upon request communicate to any firm who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds.
