Pakistan Agricultural Research Council (PARC) invites bids through EPADs (Two stage two envelop) from Authorized (License Holder) companies / Firms / contractors who deals with and provide security services and registered with GST & Income Tax Department GOP for provision of services of skilled, qualified, armed and uniformed ex-servicemen as Security Guards / Security Supervisor for a period of two years (one year extendable) at PARC HQs, NARC & other PARC premises, Islamabad out of PARC/NARC Budget. The company will pay the security guards at least minimum wages as fixed by the government. The detail of required manpower is as under:

The eligible companies/firms/contractors authorized and capable to conduct security services and enable to arrange above mentioned manpower, may bid on the terms & conditions and requirements mentioned in the tender document which can be downloaded from EPADs or received from Directorate of Procurement PARC Room # 231 (2nd Floor) on any working day from Monday to Friday till 27-11-2025 on along with pay order / bank draft amounting to **Rs.1500/-** (Non-Refundable) drawn in favor of PARC, Islamabad.

The Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit their technical and financial bids on EPADs along with all attachments as per format. The bids will be submitted on or before 27-11-2025 by 10:30 a.m., and will open on the same day at 11:00 a.m. in the presence of bidders or their representatives.

Each bid should be accompanied with **Rs.100,000/-** earnest money (Refundable) in shape of bank draft or pay order in favor of PARC, Islamabad. The conditional bids or the bids without earnest money or containing less earnest money shall not be entertained / accepted by the committee.

The payment of all taxes is the responsibility of the firms. PARC reserves the right to reject any or all bid's proposals or may cancel the tender at any time prior to acceptance of a bid or proposal. However, PARC shall upon request communicate to any company/firm or contractor who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds. PARC may decrease or increase/change in number of manpower and terms and conditions as well.
