- The certificates are required for purchase of Korean Holstein semen doses eg; (i) Pedigree record of Bull (ii) Semen quality report (iii) Dam and daughter milk record (iv) free from genetic diseases (v) accuracy of EBV for production traits (vi) A2A2 to certificate
