Subject: **FIELD TRIALS/MULTIPLICATION OF SEED POTATO PRODUCED THROUGH AEROPONICS TECHNOLOGY**

Pakistan Agricultural Research Council (PARC) and Korea Program on International Agriculture (KOPIA) are working on seed potato production through aeroponics. We are interested for field trials/seed multiplication in Punjab and Sindh by farmers/seed companies. Farmers associations/companies who fulfil the following conditions can apply within six (06) days of advertisement:

1. Variety: Lady Rosetta
2. Seed Level: Basic-I (G-2), Certified by FSC&RD
3. Maximum seed quantity provision: 20,000 tubers per farmer/company
4. Will sign MOU with KOPIA-PARC before delivery of seed and get one day training.
5. Seed will be multiplied in the field where potato crop was not planted during last two years and will follow the instructions of KOPIA
6. Seed certification and inspection by FSC&RD will be mandatory
7. 20% produce will return to KOPIA-PARC for distribution to other farmers for next year.
8. Farmer/company will multiply the seed upto stage (G-4)
9. Applications for seed having all information including previous experience should reach to Dir. KOPIA-Pakistan Centre, NARC Park Road Islamabad on or before 07-09-2023. Applications can also be sent through e-mail to : cgyoung61@gmail.com

Pakistan Agricultural Research Council (PARC) and Korea Program on International Agriculture (KOPIA) are working on seed potato production through aeroponics. We are interested for seed multiplication in Punjab and Sindh by farmers/seed companies who qualify for G-0 multiplication. Farmers associations/companies who fulfil the following conditions can apply within six (06) days of advertisement:

1. Variety: Lady Rosetta
2. Seed Level: (G-0), Certified by FSC&RD
3. Maximum seed quantity provision: 250,000 tubers
4. Minimum price/tuber is Rs. 50/-, (Fifty only)
5. Will sign MOU with KOPIA-PARC before delivery of seed and get one day training.
6. Seed will be multiplied in the field where potato crop was not planted during last two years and will follow the instructions of KOPIA
7. Seed certification and inspection by FSC&RD will be mandatory
8. Farmer/company will multiply the seed upto stage (G-4)
