To secure the official stance of Pakistan in respect of its territories Survey of Pakistan (SoP) made its tireless efforts for obtaining necessary approval from Government of Pakistan regarding **Official Map of Pakistan**. Resultantly, Government of Pakistan approved the said map titled as "**Pakistan Political**". Being a national mapping agency SoP has published the Pakistan Political map on 4th August 2020. The same can be, either, downloaded free of cost from official website i.e., www.sop.gov.pk, or can be obtained from the HQ or regional offices of the SoP on payment.

2. As per SoP mandate tremendous efforts have been made, by approaching relevant departments/ organizations, to ensure the use of correct version of said map. SoP's struggles for portraying Pakistan official stance proved to be fruitful, however, it is observed that the unofficial maps are still being used in some public & private sectors/departments/ organizations. This office already brought it in your kind notice vide SoP's No. 161/17-P-Civil/IS dated 28th January, 2022.

3. In view of above, it is requested to direct all divisions/ subordinate/ autonomous & semi-autonomous departments, and agencies to use only the official map of Pakistan for displaying in offices, official websites, books, newspapers, magazines, newsletters, etc. It is pertinent to mention that under the **Surveying and Mapping (Amendment) Act, 2020**, displaying, printing, publishing, etc., any unofficial map of Pakistan is punishable offense.
